<u>Public/Agency Education Committee Report:</u> Rob reported that he will be sending an email to the region coordinators to formulate a plan to provide some education and outreach.

<u>NJTI Updates:</u> Cecily reported that the most recent meeting has been cancelled. There is a new workgroup for Standards and Training. Eight years ago APCO and NENA had put forth a directive that there wouldn't be any TERT training allowed for teams, unless it is a FEMA training. NJTI has now changed their stance on this directive and are now encouraging

teams to train as much as possible. Cecily believes that this change should be officially approved in the near future. She will provide a further update as soon as he has one.

<u>State Coordinator Updates:</u> Thayer reported that he has reached out to the State and Director Doyle of 911 to create an updated MOU with TERT. He provided them some documentation and they will be drawing up an MOU and forwarding it to the State's legal team for review. With an updated MOU, there are hopes that some of the state employees would join NH TERT. Thayer also reported that all State Coordinators have been invited to the NENA Annual Conference to represent TERT at the trade show in TX in July. Thayer will not be attending.
